- 10:00 Enjoy a <u>guided tour at the Glenn H. Curtiss Museum</u> (8419 State Rte. 54, Hammondsport). One of the most notable in the U.S., the Museum focuses on Curtiss' innovative accomplishments as an aviation pioneer and early motorcycle manufacturer. See vintage and antique collections of aircraft, motorcycles, wooden boats, automobiles, and bicycles during your guided tour of the Museum, which is located in Curtiss' hometown.
- 12:00 pm Arrive at <u>Bully Hill Vineyards</u>, one of the most charming venues in the Finger Lakes overlooking Keuka Lake, and enjoy a <u>sit-down luncheon and wine tasting of 5 selections</u> (souvenir glass included) <u>Lunch choices</u>: <u>Bully Hill Salad</u> (mixed greens, diced apples, cranberries, etc. topped with grilled chicken); <u>Chicken Salad Sandwich</u> (mayo based topped with fresh basil, on roll): <u>Pulled Pork Sandwich</u> (with Bully Hill BBQ sauce on toasted bun); or a <u>Quiche</u> (3 cheese, onions, spinach and mushrooms served with mixed greens). <u>(Please indicate meal choice on registration form)</u> Time permitting, also visit the art gallery, wine museum and gift shop.
- Reboard your coach and visit the <u>Fingerlakes Boating Museum</u> (8231 Pleasant Valley Rd. Hammondsport) where you'll see canoes, rowboats, row outboards, outboard runabouts, inboards, hydroplanes, and sailboats. Many related artifacts and ephemera are also on display, including a 130' x 10' lake and nature mural and replica lake cottage. A 60' x 10' lake mural was also recently completed in the Inboard Motor Boat exhibit room. The main building also contains an active boat shop where visitors are able to see restoration projects underway.
- 4:00 Enjoy some free time in the lovely town of Hammondsport for shopping or viewing Keuka Lake.
- 5:00 Depart for an estimated 6:30 return to Bushnells Basin.

TERMS & CONDITIONS - DAY TOURS

Participant Agreement

By submitting a Registration Form and payment for any Bus America Day Tour, individuals agree to be bound by the terms and conditions of participation and cancellation as indicated below. Any individual tour may have additional terms and/or conditions that apply that and will be indicated on the specific tour flyer - travelers should review all tour documentation thoroughly prior to registering. Tours will be operated in accordance with all public health requirements and guidelines in place for the particular location/s at the time of the tour. Travelers will be required to cooperate with these requirements to participate, and failure to do so may result in a traveler being dismissed from a tour without refund.

<u>Price/Group Size:</u> Tour prices are based on a minimum group size. If tour enrollments do not reach the required minimum group size, Bus America will offer the travelers the option to transfer their registration to another tour or receive a refund. Operational decisions will be made no later than 2 weeks prior to a scheduled tour.

Reservation and Payment Schedule: Reservations will be confirmed when a completed Registration Form is submitted with the tour deposit or full payment as indicated on the tour flyer. Registrations are accepted by mail, by phone, or online – see Registration Form for instructions and details. Generally, full payment for Day Tours are due 30-45 days prior to departure, however, each tour flyer will indicate the due dates for deposits and balances, and/or full payment.

<u>Tour Schedule:</u> Prior to departure, Bus America will notify travelers if any changes are necessary to the pick-up, return, or activity time schedule that is indicated on the initial flyer. <u>Pick up locations are subject to change as approximately 8 travelers are needed at each pick up location</u>. Your tour manager will always do their best to adhere to the original time schedule as planned, however, cannot be held responsible for deviations or tardiness caused by unforeseen factors such as weather, traffic, etc. <u>Please arrive 10 minutes prior to the scheduled departure time, tours cannot wait for late travelers.</u>

<u>Tipping / Gratuities:</u> Gratuities for tour managers and motorcoach drivers are included in all Bus America prices. However, travelers should feel free to express their gratitude for exceptional service through additional gratuities on the day of services at their own discretion.

<u>Traveler Documentation:</u> Participants must comply with identification or documentation requirements as indicated on the tour flyer, such as a photo I.D., and/or (for Canada) a Passport, Passport Card, or Enhanced Drivers' License.

<u>Cancellation Policy:</u> Day tour cancellations are accepted by phone, mail, or email to <u>info@grouptoursinc.com</u>. Refunds will be provided within 15-30 days from the date of cancellation. The following cancellation penalties apply:
